





- On average, over 35,800 cases were filed with the 13th Circuit Court and FCC each year.
 - Filings increased over the 5-yr period by over 900 each year.
- By count, the largest increases in filings were in traffic/ordinance, associate civil/small claims and felony cases, while the largest decrease was in abuse & neglect cases.
- Traffic/ordinance cases accounted for almost one-fourth of the court's caseload, while associate civil/small claims and misdemeanor/etc. accounted for over one-fifth each and domestic relations for one-eighth (see below).
